Field Update

For those of you who don't know yet, the owners of the field have sold the property. The new oweners are planning on developing the area on the north east corner. They are planning on doing some clearing of land soon if it has not been done yet. As of the writing of this newsletter, it is still ok to go out to the field and fly.

The new owners are planning on constructing some commercial buildings on the property along with a fence. The construction should take place in the next 3-6 months.

President Mario Gonzalez as been busy trying to keep up with the property and getting in touch with the AMA. There have been various emails that I haven't e-mailed out that I will try and post in this newletter so every one will be kept up-to-date with the field.

To date, we have had one meeting held on February 23. The results of that meeting are included in this publication.

Field Meeting 2 / 23 / 2004

A meeting was held at SIMSCO to discuss the news that the field property had been sold. The purpose of the meeting was to try and get clear direction on what needed to be done immediately. In addition to this, some ideas were discussed where we should look for a new field.

Items that need to be done immediately are in relation to the new owners getting ready to tear down the front fence and gate. Since we just put up a new sign on the gate, that sign needed to be taken

down and placed in storage. (this has already been completed as of 3/10. Thanks to Greg Judy for doing that task).

Howard and Mario moved the new pylons from their position during the races up to the field.

Construction of a fence and new buildings in the north east corner of the lot should take place in 3-6 months. It is still ok to fly at the field.

STRCC needs to get our charter updated with the AMA as it is due soon. Bill Jones is handling this. Likewise, STRCC needs to provide the new owners a proof of insurance for our flying.

We will need to place the tractor in storage when we can no longer fly at the field. If anyone has a place to store the tractor, please notify a club officer.

If anyone knows who owns the old trailer at the field, notify a club officier.

Any STRCC members who are pilots and fly over the area, be on the outlook for some space where we might be able to place a field on.

Sandy Frank and the AMA have been contacted about the situation.

Mario Gonzalez has contacted Golden Triangle, GSW, and the Ft. Worth Thunderbirds about our situation. There is the possibility that these clubs may let us use their field if we loose ours. Thanks to Craig Bevil for his efforts to get STRCC in touch with GSW.

STRCC will contact the city of Arlington, Mansfield, Trinity River Authority, and the Trinity Waste Services.

That was the end of the information discussed at the meeting.

STRCC Field Status -

Just to let you know, our president, Mario Gonzalez has been out beating the bushes looking for information on what to do about this. Here is some of the e-mail traffic that has not been passed on that you might be interested in.

NOTE: Even though some of the e-mails show that an offer is being extended to the STRCC members for flying at their sites, please call Mario before proceeding to use their sites. Our site can still be used and I would not want to wear out our welcome when our field is still open for flying.

An e-mail from Mario describing the situation as he first found out about the sale of the field:

Gentlemen,

I spoke to the Wayne Winters (new owner) today over the telephone and he indicated that he was not going to make us evacuate the field immediately. However, he did say that he arranged for some bulldozers to knock off the tree line on the north side of the field which also meant that the fence was going with it. So that brings to mind the items that are in the shed and grill. We need to make some type of arrangements with someone who has the space to keep those items in the mean time or do you think that there should not be a problem leaving those items out there. He did say that he anticipated approximately 10 days before this happened. We also need to remove the signs that are hanging on the fence. Unfortunately, I do not have a vehicle that can accommodate those signs, would any of you want to take them down and keep them until we find another place? We will talk in more detail on Monday, but this is what I know now. Let me know what you think.



From Mario's collection: Feast your eyes on this engine, it is not my latest acquisition, I bought it before we had our first child (pretty sneaky!!). It is one of Jett Engineering's latest innovation (Barstock Engine, BSE), well it has been around for more than a year. Unlike it's predecessor the Sport Jett, the crankcase on this engine is machined from aluminum barstock, but the internal components, I believe, remained the same. These engines are offered in different sizes ranging from 0.25 to greater than 1.0. The reliability and performance, in my opinion, is unbelievable. This engine was effortlessly turning 10 x 6 APC prop at a rich 14,000 rpm (without a tune pipe). No Craig B. this will not be the next step up for the engine of choice for the rookie races. Anyway, if you guys are thinking of buying something with some spunk; this is the engine for you. Also, ask Joe Sudduth how he likes his Sport Jett .46.

First of all, I must confess that there was a mistake in last months race results. I had the points swapped for Duane Riedel and Joe Suduth. My apologies. Duane actually won most of the races. The points for last month should have been: Duane (20), Craig (18), Joe (17), Mario (14), and Howard (12). So just remember, Duane is really the point leader heading into the February races!

The February races were postponed for the first scheduled race day. The next Sunday was a good day for flying and we were able to get in 8 heats. I believe that ties a record of maximum heats per race day. Craig Bevil provided a count down CD to start the races. That takes some of the pressure off of the starter. And in this manner, you either have your plane ready to go, or you miss the start.

There were some good heats flown. I can think of two heats that were run neck and neck all the way through the race. It was like formation flying. Best of all, the racers were intact and will be ready for another day of racing.

The only real mishaps were that Bruce lost a portion of his muffler during a heat and Craig got started but was unable to finish a heat. All of the races were run clean with the exception of Bruce who cut once in two different heats.

Joe Sudduth was back in form crossing the finish line in first four times. Mario was next with two 1st place finishes, and Howard and Bruce each had one 1st place finish. The fastest clean heat of the day was recorded by

Joe at 2:13:61. Craig Bevil lowered his fastest clean run with a time of 2:15:87.


